2024 Pastor's Report

Pastor's Report

This report marks the 16th time that I've had the opportunity to write down some thoughts and reflections about the prior year. The first one, written after 2009, was brief on memories but full of hope. At that time my goal was to develop connections within the church and community and strengthen our relationship with God. And all this time later, I have come to realize that these are the things I still value the most.

This wasn't always the case; when I first got out of seminary and was called to my first church, I believed that if I developed the best programs and led the best meetings and gave people the best experiences that I would be successful in my pastoral calling and the church would be full of people. And yet as time has passed and countless programs, meetings, and experiences have come and gone, what remains is what matters the most: people. It is developing relationships with people that makes serving in a church worth it! I'm glad I didn't have to go my whole ministry before figuring out this fundamental truth.

Every day I find myself thinking about *people* and what they mean to me. I think about all the people we lost this past year: Sally Novak, Pat Fahrner, Alan Richardson, Kathy Sautter, Claire Moon, Evelyn Ritenour, and Otto Chanko. Last year was a difficult one due to all these deaths because they are more than just names. They are pillars of the church, teachers, friends, leaders, leaving legacies of faith. They mattered so much!

I think about all those who serve and give and love, and I am grateful that we are able to do so much good together. Every month, elders show up to meetings and ponder and pray about our present as we look to our future. Every month, deacons show up to give and share and pray for those who need it. Every month, people come to meetings and worship and fellowship and mission opportunities. And we all do this together, as one body. We gather because we love Jesus and because we know we are better together than apart. We serve because it is a joyous expression of what God is doing in our collective lives.

My lasting memory of this past year occurred one Wednesday evening in the summer. We were gathered for our bonfire worship, about to start our singing, when all of a sudden, vans full of our special needs friends started pulling up. As they piled out of the vans, I could sense that we were in the midst of a holy moment. Their smiles and laughter and joy were contagious! They came because we had made the effort to get to know so many of them over the years. It has been wonderful serving them, but that night we were united together in worship, 30 of us joining our hearts and voices in praise. It was no longer us and them; it was the body of Christ as it was meant to be. The worship brought us together, our faith brought us joy, and our enduring relationships continue to blossom and grow. Friends, this is the church.

My hope is that in 2025 our relationships with God, the community, and one another will continue to grow – for what can be better than that? May Christ be with you, always.

- Prepared and distributed contribution statements
- Provided monthly pledging updates for the Bulletin

- Prepared confidential giving analyses for the Finance and Stewardship Committee, to assist tracking to the 2024 zero budget

2024 Mission and Evangelism Annual Report

The Mission & Evangelism committee continues working to provide opportunities for our members and friends to reach outside the church and serve and love our neighbors. This year we were blessed to be able to expand our ministry to Hope clinic and Community Outreach Center thanks to you!

Hope Clinic

This year we were able to pack over 300 lunches and deliver them to their Ypsilanti headquarters. They give out 500 lunches every week.

Community Outreach Center (COC)

We affectionally call them the Friendship Club.

- 1. We started a Wednesday morning worship service. We welcomed a number of Friends and their staff for a while. It turned out that Wednesday morning was not good for their home schedules so we invited them to the Wednesday Night Campfires. Many Friends came and had an awesome time.
- 2. We had our annual Christmas Party and a summer picnic party with 170 Friends and staff. They were serenaded by the hot group Baum & Kateff.
- 3. Folks from St Timothy answered the call and have been going to some of the homes and reading to folks and helping with crafts.
- 4. The COC home in Plymouth right in the middle of town had become overgrown. Seven St. Timothy members went over and spent the better part of the day chopping and pulling. We filled 18 compost bags for pick up. A bonus was received by some poison ivy.
- 5. We sold 27 Mum plants this fall which benefited the COC.
- 6. We found out that 8 Friends had no family and were not going to get a gift for Christmas. St. Timothy took care of this and got gifts for all.

Detroit Presbytery

We supported our Presbytery's mission work again this year.

- 1. St. Timothy donated over 200 rolls of toilet paper this year.
- 2. We collected 187 boxes of cereal for food challenged kids who can't get breakfast at school during the summer.

Neighborhood

- 1. Trunk or Treat was another success this year. This year we had 20 cars and 225 children.
- 2. The Easter egg hunt was again a success. Over 60 candy craving kids ran to get the candy filled eggs hidden around the church.
- 3. Crop Walk brought together a group of neighborhood folks from Livonia to walk and put together 108 feminine kits that will be distributed to needy girls. We delivered them to Lansing where they were distributed around the world.

2024 Properties/STARS

Another year has gone by. 2024 had quite a few property and building improvements. The STARS have had a very busy year with all the upgrades along with the normal maintenance schedule. I'd like to give a big shout out to them for their dedication and expertise in maintaining the property and building.

2024 improvements include:

The kitchenette was planned and came to fruition with the help of a local electrician - Travis who volunteered his time and expertise to the project. This was a full team effort to get this project accomplished and the STARS rose to the occasion.

The big tree in the front yard had to be removed and was quite an undertaking, one that the STARS were not able to tackle ourselves.

The next big improvement was the remote access system and was quite an upgrade and change from the old key system. It had a challenging start as any new upgrade in technology can be, but in the end, we think it is working well for ease of operation and the security to the building.

Next big project was the new camera system throughout the building (including the day care area) which adds another layer of security. This upgrade has provided us with the ability to monitor who is coming and going through the building at any given time.

We added handrails to the pulpit area in the sanctuary. This was done for safety purposes and has been welcomed by the congregation.

In January of 2025 a new camera and lighting system was upgraded in the sanctuary to provide a much-improved viewing experience for streaming our Sunday service.

2025 we'll bring new challenges, but I'm confident the STARS will be able to meet these challenges with the same level of dedication that they have in the past.

Likewise, we serve the Congregation, with God's help in formulating plans meant to lead us into God's calling for St. Timothy by moving us in the direction our prayerful discernment calls us to be. Our efforts in 2024 focused on two areas:

- 1. GO TO BOARDWALK FUND-RAISER: SP worked with our Finance Committee to develop plans for a major Fund-raising campaign, which was labeled "Go To Boardwalk" playing off the popular Monopoly board game theme. The result of that planning was a communication to our Congregation most creatively made by our "resident actor" and Finance Committee member, Tim Chanko, dressed as the "Monopoly Man", proposed a **three-year \$150,000 Fund-raising campaign.** As part of that fund raising, we recommended, and Session approved, a 10% (tithe) allocation of all money contributed for St. Timothy to support community Mission needs as identified by Session and the Mission and Outreach committee.
- 2. **ST TIMOTHY FACILITY RENTALS:** The second major project undertaken by SP was to revise and reformulate a comprehensive rental policy covering the rentable areas of our building (Sanctuary, Fellowship Hall, Classrooms) that may be requested both by members and non-members. What sounds like an easy task actually gets quite complicated when you consider the distinction between members and non-members, the manner in which our facilities may be used, what is deemed to be appropriate use,

varied types of groups and or individuals seeking to rent space, appropriate rental rates, capacity of our own staff to manage a rental relationship and whether the rental use is short or long term in nature. We attempted to cover those variables in our rental policy statement (which Session did approve), and as a final step our committee drafted a standard rental contract and agreement to be used with non-member lessees.

As we approach SP in 2025, we are mindful that finances remain tight, opportunities to pass along the Gospel message may exist in the newer community right next door to us, ministering to the surrounding special needs community continues through our Friendship Club activities, other area churches are struggling to keep their head above water, and on the national front, we seem to have a new Administration strongly communicating the importance of life, faith and family. Our challenge is to be focused on process and not outcome by having the doors of St. Timothy swing from the inside out spreading the truth of the Gospel message and God's Word into the community. Please pray for divine wisdom and guidance in our planning.

From our committee participants, we continue to be blessed with a blend of personalities and experience, supported by wisdom grown in faith. Thank you one and all and thank God for your faithful hard work!

2024 Chancel Choir


