February 23, 2025 Congregational Meeting Minutes

A quorum was confirmed, and the meeting was opened with prayer by Pastor Joel at 11:29 am.

The motion to elect Kim Gaines as secretary of the congregation was made by Cassy Sautter and seconded by Ron Martin. The motion was passed by the vote of the members present.

Motion to approve the minutes of February 25, 2024, and December 15, 2024, congregation meeting was made by Linda Delezenne and seconded by Lou Suveg. The motion was passed by the vote of the members present.

The annual reports were reviewed. Chris Korne provided an update of the church properties projects. The process of turning the kitchen into a commercial kitchen has been terminated. This is due to the inspection performed by Wayne County in which it was determined that the stove hood vent needed to conform to the current fire suppression regulations. The estimate for the

project was between \$60,000.00 and \$100,000.00. Due to the cost, the session voted to terminate the issue. The boiler parts have been ordered and were installed. The boiler is back functioning again. Work is in progress with the day care. Lansing has yet to issue the license to Brilliant Butterflies.

Scott Gaines inquired about appealing the decision of Wayne County regarding the stove hood venting as it was never an issue in any of the other inspections performed during the application process. Melanie Gumz also expressed her concern that the session just accepted this and inquired if there was any thought to look into additional financing such as applying for grants. Paula Boegner responded that the Finance Committee will be looking for additional ways to use the kitchen for profit.

The motion to receive the annual reports was made by Bob Taylor and seconded by Lou Suveg. The motion was passed by the vote of the members present.

Tim Chanko presented the proposed 2025 general operating budget. Motion to receive the proposed general operating budget was made by Bob Taylor and seconded by Matt Johnson. The motion was passed by the vote of the members present.

The acceptance of pastor's 2025 terms of call from December 15, 2024, Congressional Meeting were presented.

Motion to adjourn the meeting was made by Linda Delezenne. The motion was seconded by Cassy Sautter. The motion was passed by the vote of the members present. The meeting was closed with prayer by Pastor Joel at 11:50 am.

This meeting was called to order at 11:22 AM by Pastor Joel as moderator who opened the meeting with prayer. He then confirmed the presence of Quorum plus noted that the meeting may also be viewed online. The purpose of this meeting is to first, elect new members of Session and Deacons for 2026 and second to present the Pastors Terms Of Call for 2026 for review and approval of the congregation.

The Mission and Outreach Committee continues to provide opportunities for our members and friends to serve our community, our neighbors and each other.

We have built a wonderful relationship with our Friendship Club folks. They are a part of Livonia's Community Opportunity Center. Every month we assist or host a craft class with several of their residents. We have an annual party that includes dinner and bingo. Greg Kateff, Mike Baum and Bob Taylor entertain everyone with a fun sing-along. Thank you! Some of the residents enjoy attending and participating in the summer bonfire worship services. We supported their fundraiser by ordering 40 Fall mums. Many of them participated in Trunk or Treat. The committee helped to organize a fasting weekend during Lent. It ended on Sunday with Communion and a meal. Many people participated and the feedback was positive.

Over 150 lunches were packed and delivered to Hope Clinic along with 60 boxes of cereal and diapers.

Our annual Easter Egg hunt was a lot of fun for children in the community. Over 500 eggs were filled with candy and goodies.

There were about 80 visitors to Trunk or Treat. Thank you to everyone that passed out candy from their cars and those that donated candy.

The cereal drive was a huge success. Cereal was delivered to Hope Clinic and Presbytery. We also donated over 100 rolls of toilet paper that was delivered to Presbytery.

The City of Livonia reached out with a request to help a resident with yardwork and trash removal and help we did! Thank you to those that came to help.

We had several requests from charities and organizations for monetary donations, clothing, winter accessories and toys. Contributions were made to Wycliffe Bible Translators, Mission Cry Resources, Ashes to Glory Foundation, Detroit Rescue Mission, Another Day Resource and Children's Orchards Services. A sofa and chair were donated to a family in need.

From May through October the prayer ribbons were available for anyone to write a prayer, a praise, etc. and tie to the fence.

Fellowship was offered every Sunday after worship with different themes weekly. Committees and groups signed up to help with this. Birthdays and anniversaries are celebrated on the first Sunday of each month.

The committee bought cleaning supplies to help support Crop Walk. The supplies went to communities that needed assistance cleaning up after natural disasters.

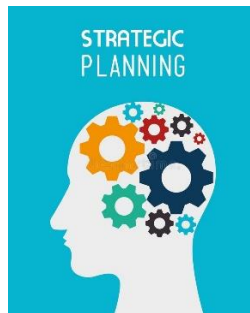

2025 Strategic Planning Committee

Committee Advisor: Pastor Joel

Strategic Planning is the process where an organization, whether it be a club, company, or church, defines its long-term vision, sets goals, identifies key priorities, and creates actionable strategies and resource plans to achieve them, essentially acting as a roadmap for future success by turning broad ideas into measurable outcomes. It involves clarifying what the organization wants to be (Mission/Vision), how it will get there (strategies/initiatives), and how it will measure success, aligning teams (Session directed committees) and resources toward common objectives. Several years ago, St. Timothy restated its Mission:

“Empowered by the Holy Spirit, our Mission is to Seek God, Follow Christ, serve and love our neighbor”.

2025, was a year characterized by Pastor Joel as a year of “discernment”. The Congregation was asked to pray over **Building Use, Finances, Invitation, and Affecting the Culture**, seeking discernment from God, that will help us formulate a more defined future Vision in support of our stated Mission. So, Strategic Planning hit the pause button as we await the gathering of ideas, thoughts, impressions our Congregation received in prayer. Our committee will assist in the gathering of your prayers, followed by a report to Session. Session will then take your prayer feedback and work towards defining a detailed future “Vision” for St. Timothy”. From that Vision we will work toward creating actionable strategies and resource plans to attain it. This is delicate work as it involves the coordination of many committees, congregational support and a whole lot of prayer. In the meantime, we will assist Session with shorter term tasks which in scope go beyond what a large governing Board can practically do. Last year those tasks included:

- **ST. TIMOTHY FACILITY RENTALS**: Completed a comprehensive rental policy covering the rentable areas of our building (Sanctuary, Fellowship Hall, Classrooms) that may be requested both by members and non-members. As a follow on to that policy we completed a standardized rental contract and agreement, which Session approved, to be used as a starting point with any non-member group wanting to rent our building and its facilities.
- **COMMUNICATIONS**: Identified the many ways we communicate both internally and externally to the community at large and began reviewing for effectiveness our communications methods and procedures. We completed a thorough review of the St. Timothy website and issued a formal report to Session. Several of the suggestions made have already been implemented.

A principal aim of strategic planning is having the doors of St. Timothy swing from the inside out spreading the truth of the Gospel message into the community. Please pray for divine wisdom and guidance in that planning.

Sue Zabell joined our committee in 2025, and from all our committee participants, we continue to be blessed with a blend of personalities and experience, supported by wisdom grown in faith. Thank you one and all and thank God for your faithful hard work!
